BACKGROUND: Indiana's court system started out with just a Circuit Court in each county, which was responsible for hearing probate cases as well as all other kinds of cases (both civil and criminal). A state law in 1829 provided for the creation of a Probate Court in each county, separate from the Circuit Court, to hear probate cases. These Probate Courts were abolished in 1853 when Indiana law created a Court of Common Pleas in each county, to help take some of the workload from the Circuit Courts. These Courts of Common Pleas existed in Indiana until 1873, when they were abolished by state law. At that time, any cases (probate or otherwise) that were pending in those courts were transferred over to the Circuit Courts to be disposed of. Circuit Courts remained the only courts in the counties until the gradual introduction of Superior Courts in the 1900s.

PROBATE COMPLETE BOOKS: A probate packet (aka "loose papers") contained all the original documents from a probate case, including any receipts that were filed. Probate cases were also referenced in probate fee books and probate order books. The official in a probate case (e.g. the administrator, executor or guardian) also had the option to have the clerk write a complete summary of the case from beginning to end, which was then recorded in a probate complete book. This complete summary was not a requirement, and it involved paying the clerk an additional fee, so most of the probate cases did not appear in the probate complete books.

NOTE: The option to have a probate case summarized in a probate complete book fell out of favor in Indiana beginning in the 1880's. In Hendricks County, after 1873 (when the Court of Common Pleas was abolished), only the land sale portion of a probate case was recorded in the probate complete books. Hendricks County's probate complete books ended entirely in 1905.

ACCESS: The Archives section of the Hendricks County Government website (www.co.hendricks.in.us) has digital versions of many of these probate complete books. Additionally, these probate complete books have all been microfilmed, and that microfilm is available locally at the Plainfield library, as well as the Indiana State Library in Indianapolis and the Family History Library in Salt Lake City, Utah. The original probate complete books are kept at the Hendricks County courthouse in Danville, Indiana.
